



#### HYPOTHETICAL CONDITIONS

- The subject parcel is owned by the State of Montana and this appraisal assumes the property is in held in private ownership. This is noted in the "Scope of Work for Appraisals of Potential Property Sales through the Land Banking Program" which is included in the addenda
- The "Scope of Work for Appraisals of Potential Property Sales through the Land Banking Program" also notes that "Landlocked parcel, (parcels with no legal access), will be appraised with the hypothetical condition of having legal access and should be appraised as the property currently exists, which is without legal access, ("as is"). This is further discussed in the highest and best use section of this report.

#### SCOPE OF THE APPRAISAL

I retained by the Montana DNRC Trust Land Management Division, State of Montana to appraise the subject parcel. I was provided the following information:

- Scope of work
- Parcel description
- Contact information for inspecting the subject property.

On April 30, 2021, I met with Deidra, Kloberdanz, Lands Section Supervisor, Trust Lands Management Division, DNRC and Jim Phillips, Ranch Manager, and Mr. Phillips drove us across the property.

The subject parcel is currently leased to Robert E. Meyer. The lessee contacted the DNRC inquiring about purchasing the subject property.

The surrounding competitive market areas was researched to find comparable market data. Real Estate agents, property owners, and real estate appraisers in the area were interviewed in an attempt to find relevant market data. This market data has been confirmed by personal contact with the buyer, seller, broker, appraiser, and/or property owner.

The valuation approach utilized in the appraisal is the sales comparison approach. The cost approach was not considered, as the property is raw land. The income approach was not utilized, as the scope of work notes the property is to be appraised in fee simple ownership and with the hypothetical condition the lease does not exist.

All of the comparable sales described in the body of the report are shown in detail on the summary sheets in a separate document. I did not physically inspect each of the comparable sales and the photos on the sales data sheet are from the Multiple Listing Service, Cadastral, or Google Earth.

#### Effective Date:

The effective date of this appraisal report is April 30, 2021. This is the date of valuation and was the actual date of the site visit. This appraisal report was completed May 24, 2021.

#### **DEFINITION OF MARKET VALUE**

Market value, as used in this report, was provided by the client and is defined as follows:

Current fair market value. (12C.F.R. § 34.42 (h) Market value means the most probable price which a property should bring in a competitive and open market under all conditions requisite to a fair sale, the buyer and seller each acting prudently and knowledgeably, and assuming the price is not affected by undue stimulus. Implicit in this definition is the consummation of a sale as of a specified date and the passing of title from seller to buyer under conditions whereby:

- (1) Buyer and seller are typically motivated;
- (2) Both parties are well informed or well advised, and acting in what they consider their own best interests;
- (3) A reasonable time is allowed for exposure in the open market;
- (4) Payment is made in terms of cash in U.S. dollars or in terms of financial arrangements comparable thereto; and
- (5) The price represents the normal consideration for the property sold unaffected by special or creative financing or sales concessions granted by anyone associated with the sale.

#### PURPOSE OF THE APPRAISAL

The purpose of this appraisal is to arrive at a supportable estimation of the market value.

#### INTENTED USE OF THE APPRAISAL AND CLIENT

The intended use is for the decision-making process concerning the potential sale of the subject parcel. The clients and intended users are the State of Montana, the Montana Board of Land Commissioners and the Department of Natural Resources and Conservation (DNRC).

#### PERSONAL PROPERTY

None

#### PROPERTY RIGHTS APPRAISED

This appraisal is made with the understanding and assumption that present ownership of the subject parcels includes all rights that may be lawfully owned, and is therefore, title in fee simple as of April 30, 2021. A fee simple

estate is subject only to the limitations imposed by the governmental powers of taxation, eminent domain, police power and escheat.

#### IDENTIFICATION OF PROPERTY AND LEGAL DESCRIPTION

The property which is the subject matter of this report consists of:

• Sale 1168 – ±640 acres | Section 36, Township 13 North, Range 12 West, Powell County, Montana.

#### **PURPORTED OWNER**

The subject parcel is owned by the State of Montana.

#### SALES HISTORY OF THE PROPERTY

The subject parcel has been owned by the State of Montana for a number of years. The parcel was nominated by the lessee and may be sold through the State of Montana's Land Banking Program.

#### HIGHEST AND BEST USE

"The reasonably probable and legal use of vacant land or an improved property, which is physically possible, appropriately supported, financially feasible, and the results in the highest value. The four criteria the highest and best use must meet are legal permissibility, physical possible, financial feasibility and maximum profitability.

The definition above applies to the highest and best use of vacant land or improved property. It is to be recognized that in cases where a site has existing improvements on it, the highest and best use may very well be determined to be different from the existing use. The existing use will continue, however, unless and until land value in its highest and best use exceeds the total value of the property in its existing use.

Quite often in estimating the highest and best use of land, the appraiser is controlled by governmental regulations. These controls are generally zoning ordinance, parking requirements and building codes. Also, in the estimate of highest and best use, one must recognize the attitude of typical investors in the marketplace.

Real estate will usually fall into certain definite development patterns, and their uses can be classified as: residential, agricultural, recreational, industrial, commercial or public use. In valuing the highest and best use of the land both as if vacant and improved, the following criteria must be met:

- 1) Legally permissible
- 2) Physically possible
- 3) Financially feasible
- 4) Maximally productive

#### HIGHEST AND BEST USE AS VACANT

#### Legally Possible

The subject property has no underlying zoning.

Based upon the location there is no apparent need for the property to be used as commercial, industrial, or by a government entity (public use).

### Physically Possible

This area is predominately agricultural lands. The subject has historically been used as agricultural grazing. The lessees land surrounds the subject parcels. The lessees fee owned land like the subject also has a recreational aspect, i.e. big game hunting.

The "Assignment Conditions" as provided by the client instruct the appraiser to appraise the property as though legal and physical access exists.

The topography of the subject parcel is overall rolling, with steep hillsides.

#### Financially Feasible

Predominate use in the area is agricultural. The area also quality land for recreational big game hunting. The subject parcels are bordered by agricultural land owned by the lessee. The lessee contacted the DNRC with respect to potentially purchasing the property through the Land Banking Program. If the sales occur the parcels would be assembled with the property owned by the lessee.

#### Maximally Productive

The use that conforms to the requirements of the first three tests and would provide the maximum productivity of the subject sites, is for continued agricultural use and assemblage.

#### **PROPERTY VALUATION**

Whenever possible, all three basic approaches to value (Cost Approach, Sales Comparison Approach and Income Approach) are utilized. The resulting indications of value are then correlated into a final estimate of market value. In this analysis I have utilized the Sales Comparison approach.

The valuation approach utilized in the appraisal is the sales comparison approach. The cost approach was not considered, as the property is raw land. The income approach was not utilized, as the scope of work notes the property is to be appraised in fee simple ownership and with the hypothetical condition the lease does not exist.

#### **DEFINITIONS**

# Sales Comparison Approach:

A set of procedures in which a value indication is derived by comparing the property being appraised to similar properties that have been sold recently, applying appropriate units of comparison and making adjustments to the sales price of the comparable properties based on the elements of comparison. The sales comparison approach may be used to value improved properties, vacant land, or land being considered as though vacant.<sup>1</sup>

The reliability of this technique is dependent upon (A) the availability of comparable sales data, (B) the verification of sales data, (C) the degree of comparability or extent of adjustment necessary for time differences, and (D) the absence of non-typical conditions affecting the sales price.

#### SITE VALUE

The sales comparison approach is the method employed to value the site as if vacant. Nine sales have been identified and are deemed the best obtained from the market. I did not identify sales of land that lack physical and legal access.

Montana is a non-disclosure State, which means sales information is not public information. Therefore, an appraiser must rely upon discussions with market participants, buyers, seller's, broker's, appraisers, and other discoverable information. In addition, agricultural lands of this type at times are not exposed to the market, as they may be purchased by an adjacent property owner.

#### Adjustments

All of the comparable properties differ somewhat from each other, and from the subject in various ways. The usual differences are for cash equivalency, market conditions, location, and a number of physical characteristics. Many of these factors, in varying degrees, are applicable in the appraisal of the subject property. When dissimilarities are found in comparable properties, they are adjusted for by adding to the comparable price when the dissimilar factor is inferior to the same factor found in the subject property. Likewise, a minus adjustment should be made when the comparable sale has a factor which is superior to that found in the subject property. The sale properties then are adjusted to the subject property.

However, in the market it is often difficult and sometimes impossible to accurately isolate a given factor. In short, one very seldom finds sales which are identical in all respects but one, and thus is able to prove conclusively the value, or lack of it, for any one factor due to a difference in sale price. Often, there are plus and minus factors which offset each other. Thus, the use of subjective judgment, to some degree, may be exercised.

Nevertheless, the differences in values are real and adjustments based on as much fact as can be found, will be made. Then, the appraiser may call upon experience to make subjective judgments.

# Property Rights

Each of the sales involves fee simple property rights. As a result, no property rights adjustments are warranted.

# Financing:

All sales are cash to the seller and no adjustment is necessary.

#### Conditions of Sale:

No non-market conditions motivating the buyer or seller involved in the transactions are known, therefore no adjustments are required.

#### Market Conditions:

Typically, in an active market an adjustment for market conditions is required to bring all comparable sales up to the effective date of the appraisal report, April 30, 2021. I identified two paired sales, which suggests the market has shown appreciation in recent years. The following table illustrates the market appreciation:


Based upon the aforementioned paired sales, a time adjustment of 2.2% to 4.8% per month was gleaned. In the sales grid to follow, I have utilized the low end of the range, or 2% per month.

#### Remaining Adjustments:

The remaining adjustments will be explained in a qualitative analysis which is an effective technique that recognizes the inefficiencies of a real estate market and the difficulty in expressing the adjustments with mathematical precision.

The land sales map follows and detailed sales sheets which further describe the sales are within a separate document for confidentially purposes.

The subject consists of 640 acres and is predominately below average grazing land, with an exceedingly small amount of timber. There are water rights with the property and two springs. One spring is very seasonal.

The following further describes the sales utilized, and in a separate document, is additional information that further describes the sales, with photographs.

<u>Sale No. 1 (\$3,273/acre adj.)</u> is 304 acres of timber/grazing land located southeast of the subject. This property is located along the east side of Highway 141. This property previously sold in 2017 for \$1,079/acre.

This sale is superior to the subject with regard to location, land use, and size, but slightly inferior with regard to water.

<u>Sale No. 2 (\$2,978/acre adj.)</u> is 400.84 acres of timber/grazing land located southeast of the subject. This property is located just east of Highway 141. A portion of this property previously sold in 2017 for \$1,457/acre.

This sale is superior to the subject with regard to location, land use, water, and size.

<u>Sale No. 3 (\$1,639/acre adj.)</u> is 1,400 acres of timber/grazing land located southeast of the subject, and south of the town of Elliston.

This sale is superior to the subject with regard to location, land use, and water, but inferior with regard to size.

<u>Sale No. 4 (\$1,639/acre adj.)</u> is 160 acres of timber/grazing land located southwest of the subject. This property is located north of I-90. The property is located adjacent to land owned by the Nature Conservancy and in close proximity to thousands of acres of public land.

This sale is superior to the subject with regard to land use, water, and size, but similar with regard to location.

<u>Sale No. 5 (\$1,151/acre adj.)</u> is 810 acres of timber/grazing land located southeast of the subject. This property is located north of Garrison. This is a remote parcel, with a year around creek.

This sale is superior to the subject with regard to land use and water, similar with regard to location, but inferior with regard to size.

<u>Sale No. 6 (\$1,935/acre adj.)</u> is 160 acres of timber/grazing land located southeast of the subject. This property is located northwest of Garrison. Chimney Creek traverses the property.

This sale is superior to the subject with regard to land use, water, and size, but similar with regard to location.

<u>Sale No. 7 (\$2,086/acre adj.)</u> is 158.76 acres of timber/grazing land located southeast of the subject. The property is located west of Highway 141.

This sale is superior to the subject with regard to location, land use, water, and size.

<u>Sale No. 8 (\$1,957/acre adj.)</u> is 304 acres of timber/grazing land located southeast of the subject. This property is located along the east side of Highway 141. This property more recently sold in 2021 for \$3,273/acre.

This sale is superior to the subject with regard to location, land use, and size, but slightly inferior with regard to water.

<u>Sale No. 9 (\$2,681/acre adj.)</u> is 446.26 acres of timber/grazing land located southeast of the subject. This property is located just east of Highway 141. A portion of this property more recently sold in 2020 for \$2,707/acre.

This sale is superior to the subject with regard to location, land use, water, and size.

The sales identified and utilized in this analysis, are the best extracted from the market. The overall market has improved significantly in recent years. To account for market appreciation, a 2% per month market adjustment has been applied. The subject has very little timber and the overall quality of the grazing aspect is below average. Each of the sales is overall superior to the subject with regard to land use, i.e., timber/grazing. The following table is an array of the adjusted price per acre for the sales:

I attempted to speak with individuals familiar with the properties. Each of the sales like the subject, have a recreational aspect, i.e. big game hunting. Each of the sales has more timberland than the subject and the overall pastureland/grazing, is superior to the subject. Based upon the overall physical characteristics of the subject, a reasonable indication of value is at the low end of the range, or \$1,150/acre. The market value of the subject \$736,000.

Montana is a non-disclosure state which means sales prices are not public information. The sales information utilized in this analysis are the best identified. Confirming sales information is difficult at best and the data utilized in this analysis is considered appropriate in determining a value for the subject. 

This insurance shall cover such claims as may be caused by any negligent act or omission.

- <u>12.6 Deductibles and Self-Insured Retentions.</u> Any deductible or self-insured retention must be declared to and approved by the State. At the request of the State either: (1) the insurer shall reduce or eliminate such deductibles or self-insured retentions as pertain to the State, its officers, officials, employees, or volunteers; or (2) at the expense of Contractor, Contractor shall

procure a bond guaranteeing payment of losses and related investigations, claims administration, and defense expenses.

12.7 Certificate of Insurance/Endorsements. # 17. INTELLECTUAL PROPERTY/OWNERSHIP

17.1 Mutual Use. Contractor shall make available to the State, on a royalty-free, non-exclusive basis, all patent and other legal rights in or to inventions first conceived and reduced to practice or created in whole or in part under this contract, if such availability is necessary for the State to receive the benefits of this contract. Unless otherwise specified in a statement of work, both parties shall have a royalty-free, nonexclusive, and irrevocable right to reproduce, publish, or

otherwise use copyrightable property created under this contract. This mutual right includes (i) all deliverables and other materials, products, modifications that Contractor has developed or prepared for the State under this contract; (ii) any program code, or site- related program code that Contractor has created, developed, or prepared under or primarily in support of the performance of its specific obligations under this contract; and (iii) manuals, training materials, and documentation. All information described in (i), (ii), and (iii) is collectively called the "Work Product".

- <u>17.2 Title and Ownership Rights.</u> The State retains title to and all ownership rights in all data and content, including but not limited to multimedia or images (graphics, audio, and video), text, and the like provided by the State (the "Content"), but grants Contractor the right to access and use Content for the purpose of complying with its obligations under this contract and any applicable statement of work.
- <u>17.3 Ownership of Work Product</u>. Contractor shall execute any documents or take any other actions as may reasonably be necessary, or as the State may reasonably request, to perfect the State's ownership of any Work Product.
- 17.4 Copy of Work Product. Contractor shall, at no cost to the State, deliver to the State, upon the State's request during the term of this contract or at its expiration or termination, a current copy of all Work Product in the form and on the media in use as of the date of the State's request, or such expiration or termination.
- 17.5 Ownership of Contractor Pre-Existing Materials. Contractor retains ownership of all literary or other works of authorship (such as software programs and code, documentation, reports, and similar works), information, data, intellectual property, techniques, subroutines, algorithms, methods or related rights and derivatives that Contractor owns at the time this contract is executed or otherwise developed or acquired independent of this contract and employed by Contractor in connection with the services provided to the State (the "Contractor Pre-existing Materials"). Contractor Pre-existing Materials are not Work Product. Contractor shall provide full disclosure of any Contractor Pre-Existing Materials to the State before its use and to prove its ownership. If, however, Contractor fails to disclose to the State such Contractor Pre-Existing Materials, Contractor shall grant the State a nonexclusive, worldwide, paid-up license to use any Contractor Pre-Existing Materials embedded in the Work Product to the extent such Contractor Pre-Existing Materials are necessary for the State to receive the intended benefit under this contract. Such license shall remain in effect for so long as such Pre-Existing Materials remain embedded in the Work Product. Except as otherwise provided for in Section 17.3 or as may be expressly agreed in any statement of work, Contractor shall retain title to and ownership of any hardware it provides under this contract.

- 19. CONTRACT PERFORMANCE ASSURANCE N/A
- 20. CONTRACT TERMINATION
- **20.1 Termination for Cause with Notice to Cure Requirement.** The State may terminate this contract in whole or in part for Contractor's failure to materially perform any of the services, duties, terms, or conditions contained in this contract after giving Contractor written notice of the

stated failure. The written notice must demand performance of the stated failure within a specified period of time of not less than 14 days. If the demanded performance is not completed within the specified period, the termination is effective at the end of the specified period.

- <u>20.2 Termination for Cause with Notice to Cure Requirement.</u> Contractor may terminate this contract for the State's failure to perform any of its duties under this contract after giving the State written notice of the failure. The written notice must demand performance of the stated failure within a specified period of time of not less than 14 days. If the demanded performance is not completed within the specified period, the termination is effective at the end of the specified period.
- 20.3 Reduction of Funding. The State must by law terminate this contract if funds are not appropriated or otherwise made available to support the State's continuation of performance of this contract in a subsequent fiscal period. (18-4-313(4), MCA.) If state or federal government funds are not appropriated or otherwise made available through the state budgeting process to support continued performance of this contract (whether at an initial contract payment level or any contract increases to that initial level) in subsequent fiscal periods, the State shall terminate this contract as required by law. The State shall provide Contractor the date the State's termination shall take effect. The State shall not be liable to Contractor for any payment that would have been payable had the contract not been terminated under this provision. As stated above, the State shall be liable to Contractor only for the payment, or prorated portion of that payment, owed to Contractor up to the date the State's termination takes effect. This is Contractor's sole remedy. The State shall not be liable to Contractor for any other payments or damages arising from termination under this section, including but not limited to general, special, or consequential damages such as lost profits or revenues.

# 21. EVENT OF BREACH – REMEDIES

**21.1 Event of Breach by Contractor.** Any one or more of the following Contractor acts or omissions constitute an event of material breach under this contract:

- Products or services furnished fail to conform to any requirement;
- Failure to submit any report required by this Contract;
- Failure to perform any of the other terms and conditions of this Contract, including but not limited to beginning work under this Contract without prior State approval or breaching Section 26.1, obligations; or
- Voluntary or involuntary bankruptcy or receivership.

**21.2 Event of Breach by State.** The State's failure to perform any material terms or conditions of this contract constitutes an event of breach.

- **21.3 Actions in Event of Breach.** Upon Contractor's material breach, the State may:
  - Terminate this contract under section 20.1; or
  - Treat this contract as materially breached and pursue any of its remedies under this contract, at law, or in equity.

Upon the State's material breach, the Contractor may:

- Terminate this Contract under Section 20.2 and pursue any of its remedies under this Contract, at law, or in equity; or
- Treat this Contract as materially breached and, except as the remedy is limited in this Contract, pursue any of its remedies under this Contract, at law, or in equity.

#### 22. FORCE MAJEURE

Neither party is responsible for failure to fulfill its obligations due to causes beyond its reasonable control, including without limitation, acts or omissions of government or military authority, acts of God, materials shortages, transportation delays, fires, floods, labor disturbances, riots, wars, terrorist acts, or any other causes, directly or indirectly beyond the reasonable control of the nonperforming party, so long as such party uses its best efforts to remedy such failure or delays. A party affected by a force majeure condition shall provide written notice to the other party within a reasonable time of the onset of the condition. In no event, however, shall the notice be provided later than 5 working days after the onset. If the notice is not provided within the 5 day period, then a party may not claim a force majeure event. A force majeure condition suspends a party's obligations under this contract, unless the parties mutually agree that the obligation is excused because of the condition.

## 23. WAIVER OF BREACH

Either party's failure to enforce any contract provisions after any event of breach is not a waiver of its right to enforce the provisions and exercise appropriate remedies if the breach occurs again. Neither party may assert the defense of waiver in these situations.

#### 24. CONFORMANCE WITH CONTRACT

No alteration of the terms, conditions, delivery, price, quality, quantities, or specifications of the contract shall be granted without the State prior written consent. # **CLIENT, INTENDED USERS, PURPOSE AND INTENDED USE:**

The clients are the State of Montana, the Montana Board of Land Commissioners (Land Board) and the Department of Natural Resources and Conservation (DNRC). The intended users are the State of Montana, the Montana Board of Land Commissioners (Land Board), the Department of Natural Resources and Conservation (DNRC) and Lessee Robert E. Meyer. The purpose of the appraisal is to provide the clients with a credible opinion of current fair market value of the appraised subject property and is intended for use in the decision making process concerning the potential sale of said subject property.

#### **DEFINITIONS:**

Current fair market value.
